My parents met in the home of some friends of her parents. Herman, my Dad was playing cards with some of his friends at his brother's house. My mothers parents lived across the street from my Dads brother and sister in law, Polly and Max Holtzman. Katie my mother had just broken off an engagement with another young man. Her parents and Herman's brother and sister in law wanted Herman to meet Katie.

Katie came home from work and was asked by her father, Abraham Richman to go and get her mother, Esther who was visiting with the Holtman family. She was instructed to tell her mother come home and prepare dinner. This was all preplanned as a way to introduce Herman and Katie. Katie, not knowing that the task had a different objective, went across the street to call her mother home.. My mother entered the apartment. My Dad who was playing cards with some friends, stopped playing cards. He was so immediately attracted to my mother that he broke up the game. He invited Katie to go for a walk with him. He always claimed that it was love at first sight. That first walk was a long. cold walk. It was November with snow covering the ground and houses. My Mom did not have a hat. Her hair was white with snow which was blowing. Herman offered his hat, but she was not used to wearing hats and did not accept the offer. Neither of them seemed to be unduly concerned with cold as they talked became acquainted with each other.

He took Katie home and asked her for a date for the next night. She said, he would have to call her. This was a little perplexing to him since he was asking her in person. After returning to his brother's apartment, he called Katie for their first date. They dated three consecutive nights. On the third night he asked Katie to marry him.

Her response was No although he was a very handsome, well-dressed New York salesman who was very attractive to Katie. Katie had only two months previously broken off an engagement which had already set a marriage date. She was not anxious to start a new romantic involvement. Herman was aware of Katie's previous engagement and was very understanding of her standoffishness.

Being a traveling salesman, his evenings were free and uncommited. Herman and Katie dated every night for two weeks. She was not satisfied with the wedding at the court house. She spent the night in the home of Herman's brother and sister-in-law, the and property Holtzman. The next morning, Katie left for Montreal.

They corresponded through the next five months, making their wedding plans and future plans. The wedding date was set for June 8, 1929. Herman arrived a few days before the wedding. It was a very large wedding event, held in a hall with an orchestra. A Rabbi presided over the traditional Jewish ceremony. That night the newlyweds slept in the home of Polly and Max.

Next morning Katie and Herman boarded a train for New York. Ten hours later they arrived in New York. Herman escorted his new bride to their home which was actually a rented room in a private home. The house was located closed to the laundry business which Herman had started in January. Katie shared the kitchen with the owner while they saved up monies to move into their own apartment. Herman had spent his savings in opening up his new laundry business. The laundry required 4 employees, in addition to Katie who worked at the desk.

They lived comfortably in their rented room until Katie got pregnant. Mrs. Littenberg, their landlady recognized the need for the young couple to move out into their own apartment. She helped Katie locate a small apartment on Ocean avenue where Irwin was born. He was born June 30, 1931.

Irwin's birth was easy and he was a very easy baby to take care of. He was a happy baby who slept well and ate well. He started eating solid foods at 5 months. Once he was so eager to nurse that his tongue seemed to stick to the roof of his mouth. Katie put her hand into his mouth and she and Barnie took Irwin to the emergency. The doctor said it was a life saver because, Irwin could have choked on his tongue.

When Irwin was a year old, the family moved into 2177 E. 21st St. into apartment 20 . When Irwin was 14 months old, he won a beauty contest. It was a contest held in Brooklyn. The photographer shot him in the nude which resulted in it not being accepted by the New York Daily News newspaper. However, the winning picture remained in the Brooklyn photographers window for 4 years.

When Irwin was three years old, the family moved into apartment 205 which was a little bigger. Irwin and his brother Jack, who was born two years after this move, were raised in that apartment. Katie and Herman remained there after the boys moved away and were married.
